# 2019 IMPACT REPORT



Thanks to the commitment of its dedicated supporters, Personal PAC helped to improve the lives of Illinois women in 2019 primarily through the passage of the Reproductive Health Act (RHA). This historic bill establishes an individual's fundamental right to make decisions about their reproductive health. Additionally, Personal PAC honored leaders of choice at its Annual Awards Luncheon where needed funds were raised to ensure the election of pro-choice leaders in 2020. Personal PAC is proud of its progress over the past year but recognizes the challenging road ahead to repeal the dangerous Parental Notice of Abortion Act and continue to safeguard reproductive rights for future generations.

# VICTORIES

## **REPRODUCTIVE HEALTH ACT (RHA)**

While *Roe* was under attack across the country this past year, Personal PAC worked hard to ensure Illinois advanced reproductive rights. A tremendous win in safeguarding reproductive health in Illinois and across the Midwest was the passage of the Reproductive Health Act (RHA).

The RHA recognizes that abortion is healthcare, not criminal activity. The bill repealed Illinois' outdated abortion law so the state treats abortion care like all healthcare, with regulations that reflect current medical standards. The bill affirms that "women, not politicians, make the decisions" about their reproductive health, including their birth control and their decision to have an abortion.

This vital law modernizes and updates Illinois' laws from the 1970's to establish the necessary access to reproductive healthcare.

Without the RHA, Illinois could have faced a lack of insurance coverage for abortion care and birth control, mandatory spousal consent for abortion, 24-hour waiting periods, criminal penalties for a doctor performing an abortion, misinformed consent, and bans on assisted reproductive techniques like IVF. We refused to go back and prevailed!

Personal PAC worked tirelessly to educate the public, move voters to contact their representative on behalf of the RHA, and urge elected officials to stand up for reproductive justice. Elected officials endorsed by Personal PAC in 2018 were the deciding factors in the vote to pass the RHA, reminding us just how much elections matter.

Personal PAC wants to thank all of our friends and partners who fought by our side and Governor Pritzker, who signed the bill into law on June 12, 2019.

# **IT'S PRO-CHOICE OR NO CHOICE!**

## **THE CHALLENGE**

The Reproductive Health Act (RHA) moves Illinois closer to being one of the strongest states in favor of reproductive health. As we see more and more healthcare restrictions enacted in states surrounding Illinois, the need for Illinois to remain a safe haven for women throughout the Midwest continues to grow. Unfortunately, Illinois' label as a reproductive healthcare oasis in the middle of the country also puts a target on our back.

Anti-choice groups want to eradicate access to abortion and birth control and are winning battles across the Midwest. The next step for them to accomplish this goal will be to fund anti-choice extremists to replace Illinois' pro-choice leaders in 2020 and create an anti-choice majority in the General Assembly. Most at risk are the recently elected representatives who helped pass the RHA. Heavy funding for these anti-choice candidates will arrive from not only anti-choice groups in Illinois but from extremists across the country.

The only way for us to counteract these opponents is with resources directed at supporting both our pro-choice incumbents and future pro-choice leaders who can replace current anti-choice politicians. The statement "elections matter" has never hit home for people more that it will in 2020 on both a national and state level. One election can wipe out all of the progress we have made. One election can reverse the makeup of Illinois General Assembly. One election can see the repeal of both HB40 and the RHA.

# **STRATEGIES THAT WORK**

Personal PAC is fortunate to have partnerships with likeminded organizations whose shared belief in a women's right to choose brings everyone together to achieve a common goal – keeping the women of Illinois safe.

Through regular strategy meetings, we work together to:

- · Support online and social media efforts for pro-choice leaders
- · Lead canvassing efforts to shed light on anti-choice extremists
- Encourage constituents to contact their legislators about important pro-choice legislation
- Inspire legislators to sponsor and support historic pro-choice legislation
- Identify and recruit new pro-choice candidates
- Promote the candidacy of new pro-choice leaders



By combining resources, Personal PAC has found ways to be even more effective with its donors' dollars in ensuring that every woman in Illinois has equal access to safe and affordable reproductive healthcare, including contraception and abortion, without government interference.

## THE 26<sup>TH</sup> ANNUAL AWARDS LUNCHEON

# LOOKING AHEAD

There is little time to celebrate the passing of the RHA with anti-choice politicians fighting for its repeal and national anti-choice organizations gearing up to fund anti-choice candidates in 2020. With that in mind, Personal PAC will be focused on two key goals in 2020:

- Repealing the Parental Notice Act of Abortion (PNA) and
- · Protecting and expanding the Illinois General Assembly's pro-choice majority

## **REPEAL PARENTAL NOTICE**

Why is it important that we repeal the Parental Notice of Abortion Act requiring healthcare providers to alert an adult family member 48 hours before performing an abortion on patients under the age of 18?

The American Academy of Pediatrics contends that parental notification and consent laws can lead to serious harm. "There is evidence," the group's policy states, "that such legislation . . . increases the risk of medical and psychological harm to the adolescent." Some of their reasons include:

- Not all parents are good parents
- Volatile home environments put individuals at risk for being thrown out of their homes
- A family member may be the young woman's sexual abuser
- The judicial bypass process (which is 99.5% successful) forces them to miss school, presents immense logistical hurdles, and can grossly delay their procedure

Personal PAC is implementing a multi-step strategy that will protect reproductive rights for all women in Illinois through 2032. With the first step – supporting the election of a pro-choice Governor and Attorney General – accomplished, Personal PAC is now directing its attention toward removing remaining reproductive rights restrictions that impede a woman's access to a safe and legal abortion.

Repealing this forced parental involvement law will provide more security for the women of Illinois and those from other states who come here for safe reproductive healthcare. To learn more about the repeal bill, please visit our website at www.personalpac.org.
